Plastic Enterprises, is hereby granted authorization under section 18(6) and 18(7) of Hazardous & Other Waste (Management and trans boundary Movement) Rules, 2016 for Collection and transportation of Empty Barrels/ Containers/ Liners contaminated with hazardous chemicals/ waste (categorized under 33.1 of Schedule –I of Rules) generated from units operating in Delhi for reconditioning at its unit located at 96/6, Arya Nagar Industrial Area, Loni, Ghaziabad, Uttar Pradesh-201102.

- 4. The authorization shall be valid for a period of 5 years i.e upto 17/01/2024.
- 5. No Objection Certificate is also hereby granted under section 18(6) and 18(7) of Hazardous & Other Waste (Management and trans boundary Movement) Rules, 2016 for Collection and transportation of Empty Barrels/ Containers/ Liners contaminated with hazardous chemicals/ waste (categorized under 33.1 of Schedule –I of Rules) generated from units operating in Delhi for re-conditioning at its unit located at 96/6, Arya Nagar Industrial Area, Loni, Ghaziabad, Uttar Pradesh-201102.
- 6. This authorization is subject to following conditions:
 - i. Empty Barrels/ Containers/ Liners contaminated with hazardous chemicals/ waste (as categorized under 33.1 of Schedule –I of Rules) shall be collected only from the units having valid Consent to operate under Air (Prevention & Control of Pollution) Act, 1981 & Water (Prevention & Control of Pollution) Act, 1974 and authorization under Hazardous and Other Wastes (Management and Trans boundary Movement) Rules, 2016 from Delhi Pollution Control Committee.
 - ii. The unit shall comply with the provisions of Environment (Protection) Act, 1986 and the Rules made there under. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Delhi Pollution Control Committee.
- iii. The unit (receiver-cum-transporter) shall follow the manifest system as stipulated under Rule 19 of the Hazardous & Other Wastes (Management & Trans-boundary Movement) Rules, 2016 and submit copy 7(Grey color) of the manifest to DPCC.

- iv. While transporting the hazardous waste from Delhi to Ghaziabad, the unit shall follow guidelines for transportation of hazardous waste and the Central Motors Vehicle Act, 1988 and other guidelines issued by Central Pollution Control Board from time to time.
- v. The person authorized shall be liable for damages to the environment resulting due to improper handling of hazardous waste and shall be liable to pay the fine as levied by Delhi Pollution Control Committee under the Rules/ NGT orders.
- vi. The person authorized shall comply with the provisions outlined in the Central Pollution Control Board guidelines on Implementing Liabilities for Environmental Damages due to Handling and disposal of Hazardous Waste.
- The authorized person/agency shall ensure that no adverse impact on the air, soil and water including groundwater takes place due to activities for which authorization has been granted. Comprehensive safety measures must be followed in handling of wastes and the staff must be properly trained.
- viii. In case of occurrence of an accident while transporting the waste, complete details on form I must be sent to Delhi Pollution Control Committee at the earliest along with details of remedial measures taken.
- ix. The authorization may be treated as cancelled if the Consent to Operate under Air (Prevention & Control of Pollution) Act, 1981 and under Water (Prevention & Control of Pollution) Act, 1974 & Authorization under the hazardous and Other Waste (Management and Trans boundary Movement) Rules, 2016 granted by U. P. Pollution Control Board expires or revoked/cancelled.
- x. An application for the renewal of an authorisation shall be made at least one month in advance before expiry of this authorization.
- xi. The unit shall abide by any other conditions for compliance as per the Guidelines issued by the Ministry of Environment, Forest and Climate Change or Central Pollution Control Board from time to time and the U.P. State Pollution Control Board.
- xii. Annual return shall be filed the unit by June 30th of the current year for the previous financial year containing details of the units from where the hazardous waste is collected alongwith date and month, the quantity collected and final mode of disposal.
