Sub.: Establishment of Control Room to monitor Enforcement of SUP Ban.

The Central Pollution Control Board vide its letter dated 30.06.2022 has issued directions Under Section 5 of the Environment (Protections) Act, 1986 to SPCBs/PCCs & UDDs for implementation of ban on Single Use Plastic (SUP), wherein it was directed to set up a Control Room to facilitate activities related to the effective implementation of SUP Ban.

In compliance of the said directions, Delhi Pollution Control Committee has set up a Control Room to facilitate activities related to effective implementation of SUP ban including following:-

- (a) Provide assistance, guidance, clarification and information as may be sought by various stakeholders regarding ban on SUP items, which may include but not limited to the following:
  - Specific items covered under/ excluded from SUP Ban.
  - · Alternatives to banned SUP items and their availability in the NCT of Delhi.
  - Guidance for filing of Complaints on SUP Public Grievance App.
  - Guidance for operation of SUP Compliance Monitoring Portal by ULBs.
  - Issues related to switching over to Alternatives including Issue of Consent/ Registration to Plastic producers (Consent Mechanism/ OCCMS/ Closure Notice/ Renewal).
  - Compostable plastic manufacturers [Certification procedure, testing facilities, certified compostable plastic manufacturers].
- (b) The Control Room shall monitor enforcement of SUP ban through ULBs and concerned Authorities.
- (c) Coordination of activities related to Awareness campaign on SUP.
