OFFICE ORDER

In pursuance of the directions from Commission for Air Quality Management of NCR Region and adjoining areas and the Chief Secretary, Delhi it is decided that Construction and demolition activity in NCT of Delhi has to be undertaken only after ensuring the Dust Mitigation Measures as prescribed from time to time.

Hon'ble National Green Tribunal has passed certain directions for controlling environment pollution in Delhi and also fixed compensation to be paid for violation in term of the Section 15 of the National Green Tribunal Act, 2010 for polluting the environment.

In pursuance to NGT orders, decision taken by Chief Secretary, Delhi and in compliance of CAQM directions dated 01.09.2021, following teams of DPCC are hereby constituted (in supersession of this office order of even no. dated 05.10.2021) to perform following tasks:

1. To ensure that construction activities on plot size of 500 Sqm & above, to built-up area of 20000 Sqm are adhering to prescribed norms/guidelines and taking adequate measures for dust management.
2. Identify major air polluting sources (open burning of garbage, biomass, waste plastic, rubber, tyres, dumping of C&D Waste and garbage etc with emphasis on hotspot) and on spot reporting on 'Green Delhi App'.
3. To take quick action on redressal of complaints on 'Green Delhi App' to curb pollution activities.
4. To carry out inspection of industries to check valid consent to Operate, use of only approved fuels and to ensure that the pollution control measures are in place.
5. To identify and take stringent action against illegal polluting units in notified/ Redevelopment Industrial Areas.
6. To carry out night patrolling and surprise inspections/special drives during peak hours, non-peak hours, working days and weekends from October 8, 2021 to February 28, 2022.

Teams are authorised to issue Show Cause Notice (format enclosed) on spot for levying Environmental Compensation on defaulters/ violators. Teams are directed to maintain photographs as evidence.

Subject:- Show Cause Notice for imposing Environmental Compensation (EC) .

Whereas, Delhi is facing air pollution above the prescribed levels and the air quality w.r.t. levels of pollutants like Particulate Matter (PM_{2.5}& PM₁₀) is deteriorating thereby affecting public health. Activities related to construction and demolition have been identified as one of the major sources of air pollution and continuation of such activities without proper dust pollution control measures aggravate the situation.

And whereas, Hon'ble Supreme Court of India and Hon'ble National Green Tribunal in various orders have directed Government of NCT of Delhi to initiate steps to curb the dust pollution. The Hon'ble National Green Tribunal has passed certain directions for controlling environment pollution in Delhi and also fixed compensation to be paid for violation in term of the Section 15 of the National Green Tribunal Act, 2010 for polluting the environment.

In pursuance of the directions from Commission for Air Quality Management of NCR Region and adjoining areas and the the Chief Secretary, Delhi it is decided that Construction and demolition activity in NCT of Delhi has to be undertaken only after ensuring the Dust Mitigation Measures as prescribed from time to time.

And whereas, copies of the Hon'ble Tribunal orders, MoEF&CC guidelines on the subject and public notice issued are available at the DPCC website "<http://dpcc.delhigovt.nic.in>" for general awareness of the stake holders.

And whereas, during the visit of construction site at

..... by the team of DPCC officials on discrepancies (marked as 'Non-complied' or 'X') observed wrt. dust pollution control guidelines are as under:

Sl. No.	Dust Mitigation Measures	Complied (C) / Non-complied (X) / N.A.
1	Dust/wind breaking walls of appropriate height around the periphery of the construction site.	
2	Tarpaulin or green-net on scaffolding around the area under-construction and the building.	
3	All vehicles including carrying construction material and construction debris of any kind should be cleaned and wheels washed.	
4	All vehicles carrying construction material and construction debris should be fully covered and protected.	
5	All construction debris and construction material of any kind should be stored on the site and not dumped on public roads or pavements.	

6	No loose soil or sand or Construction & Demolition Waste or any other construction material that causes dust shall be left uncovered.	
7	No grinding and cutting of building materials in open area. Wet-jet should be used in grinding and stone cutting.	
8	Unpaved surfaces and areas with loose soil should be adequately sprinkled with water to suppress dust.	
9	Construction and demolition waste should be recycled on-site or transported to authorized recycling facility and due record of the same should be maintained.	
10	Every worker working on construction site and involved in loading, unloading and carriage of construction material and construction debris should be provided with dust-mask to prevent inhalation of dust particle.	
11	Arrangement should be provided for medical help, investigation and treatment to workers involved in the construction of building and carry of construction material and debris relating to dust emission.	
12	Roads leading to or at construction sites must be paved and blacktopped i.e. metallic roads (for >20,000 sqmt built up area).	
13	Installation of Anti Smog Gun(s) (for >20,000 sqmt built up area).	
14	Dust mitigation measures shall be displayed prominently at the construction site for easy public viewing.	

Now therefore, in compliance of the orders of Hon'ble National Green Tribunal and as per the "Polluter Pays" principle it is proposed to levy/impose Environmental Compensation(EC) of Rs. (Rupees) on the above said project proponent / owner/occupier (hereinafter referred as the addressee) for the deficiencies observed at above said site/ address for damage caused to the environment.

By-way of this notice, the you (the addressee) are hereby required to Show Cause as to why the above said Environmental Compensation (EC) should not be imposed on you (the addressee) for non-compliance with the guidelines for dust pollution control and causing damage to the environment.

Your reply (if any) along with supporting documents and rectification measures taken should reach to this office **within 02 days from the date of issue of this notice**. In case of failure, it will be presumed that you (the addressee) have nothing to say in this regard and the aforementioned EC shall be imposed without any further reference in this regard.
