### Sub:- Dust Management measures at Construction Sites

Please refer to letter No.DPCC.EIACELL-2590 to 2601 dated 01.10.2021 issued under the signature of Member Secretary, Delhi Pollution Control Committee, Department of Environment, Govt. of NCT of Delhi regarding dust mitigation measures at construction sites.

- 1. Dust/wind breaking walls of appropriate height around the periphery of the construction site.
- 2. Installation of Anti Smog Gun(s) (for >20,000 Sq.mt built up area)
- 3. Tarpaulin or green-net on scaffolding around the area under construction and the building.
- 4. All vehicles including carrying construction material and construction debris of any kind should be cleaned and wheels washed.
- 5. All vehicles carrying construction material and construction debris should be fully covered and protected.
- 6. All construction debris and construction material of any kind should be stored on the site and not dumped on public roads or pavements.
- 7. No loose soil or sand or construction & demolition waste or any other construction material that causes dust shall be left uncovered.
- 8. No grinding and cutting of building material in open area. Wet-jet should be used in grinding and stone cutting.
- 9. Unpaved surface and areas with loose soil should be adequately sprinkled with water to suppress dust.
- 10. Roads leading to or at construction sites must be paved and blacktopped i.e. metallic roads (for >20,000 Sqmt built up area).
- 11. Construction and demolition waste should be recycled on-site or transported to authorized recycling facility and due record of the same should be maintained.
- 12. Every worker working on construction site and involved in loading, unloading and carriage of construction material and construction debris should be provided with dust-mask to prevent inhalation of dust particle.
- 13. Arrangement should be provided for medical help, investigation and treatment to workers involved in the construction of building and carry of construction material and debris relatable to dust emission.
- 14. Dust mitigation measures shall be displayed prominently at the construction site for easy public viewing.

Directions dated 13.01.2019 of the Hon'ble Supreme Court of India in Writ Petition (C) No. 13029/1985 in the matter of "MC Mehta Vs UOI & Ors" regarding Deployment of Anti-Smog Gun (s), MoEF&CC, Government of India Notification No. G.S.R.94(E) dated 25.01.2018 read alongwith Hon'ble National Green Tribunal order dated 04.12.2014 & 10.04.2015 in O.A.No. 21 of 2014 and O.A. No. 95 of 2014 in the matter of "Vardhaman Kaushik Vs Union of India & Others and Sanjay Kulshrestha Vs Union of India & Others and directions issued by commission of Air Quality Management (CAQM) regarding

Reference letter No.DPCC.EIACELL-2590 to 2601 dated 01.10.2021 issued under the signature of Member Secretary, Delhi Pollution Control Committee, Department of Environment, Govt. of NCT of Delhi regarding dust mitigation measures at construction sites.

In supersession to the earlier Office Order No. 53/DC/SZ?2021 dated 05.10.2021, the following officers are directed to ensure construction/demolition activities in respective jurisdiction are undertaken only after compliance of following measures:-

- 1. Dust/wind breaking walls of appropriate height around the periphery of the construction site.
- 2. Installation of Anti Smog Gun(s) (for >20,000 Sq.mt built up area)
- 3. Tarpaulin or green-net on scaffolding around the area under construction and the building.
- All vehicles including carrying construction material and construction debris of any kind should be cleaned and wheels washed.
- 5. All vehicles carrying construction material and construction debris should be fully covered and protected.
- All construction debris and construction material of any kind should be stored on the site and not dumped on public roads or pavements.
- No loose soil or sand or construction & demolition waste or any other construction material that causes dust shall be left uncovered.
- No grinding and cutting of building material in open area. Wet-jet should be used in grinding and stone cutting.
- Unpaved surface and areas with loose soil should be adequately sprinkled with water to suppress dust.
- 10.Roads leading to or at construction sites must be paved and blacktopped i.e. metallic roads (for >20,000 Sqmt built up area).

- 11. Construction and demolition waste should be recycled on-site or transported to authorized recycling facility and due record of the same should be maintained.
- 12. Every worker working on construction site and involved in loading, unloading and carriage of construction material and construction debris should be provided with dust-mask to prevent inhalation of dust particle.
- 13. Arrangement should be provided for medical help, investigation and treatment to workers involved in the construction of building and carry of construction material and debris relatable to dust emission.
- 14.Dust mitigation measures shall be displayed prominently at the construction site for easy public viewing.

In this regard, the ward-wise following Teams have been deployed for day and night patrolling for ensuring the dust-mitigation measures as mentioned above.



Sub:- Dust management measures at Construction sites: Directions dated 13.01.2019 of the Hon'ble Supreme Court of India in WP(Civil) 13029/1985 in the matter of MC Mehta vs UOI & Ors regarding deployment of Anti Smog Gun(s), MoEF&CC, GOI Notification no. G.S.R.94(E) dated 25.01.2018 read along with Hon'ble National Green Tribunal order dated 04.12.2014 & 10.04.2015 in O.A. No 21 of 2014 and O.A. No 95 of 2014 in the matter of Vardhaman Kaushik Vs Union of India & others and Sanjay Kulshreshtha Vs Union of India & others and directions issued by commission of Air Quality Management(CAQM) regarding.

A letter has been received vide No. DPCC. EIACELL-2590 to 2601 dated 01.10.2021 (copy enclosed for ready reference) and supersession of previous letters No. DC/WZ/SDMC/2021/D-950 dated 05.10.2021 & No 544 dated 11.10.2021 regarding the construction/demolition activity in NCT of Delhi be undertake only after ensuring the Dust Mitigation Measures prescribed as follows:

- Dust/wind breaking walls of appropriate height around the periphery of the construction site.
- 2. Installation of Anti Smog Gun(s) (for>20,000 sq.mt, built up area).
- 3. Tarpaulin or green-net on scatfolding around the area under-construction and the building.
- 4. All vehicles including carrying construction material and construction debris of any kind should be cleaned and wheels washed.
- All vehicles carrying construction material and construction debris should be fully covered and protected.
- All construction debris and construction material of any kind should be stored on the site and not dumped on public roads or pavements.
- 7. No loose soil or sand or construction & Demolition Waste or any other construction material that cause dust shall be left uncovered.
- 8. No grinding and cutting of building materials in open area. Wet-jet should be used in grinding and stone cutting.
- Unpaved surfaces and areas with loose soil should be adequately sprinkled with water to suppress dust.
- 10. Roads leading to or at construction sites must be paved and blacktopped i.e metallic roads (for >20,000 Sq.mt. built up area).
- Construction and demolition waste should be recycled on-site or transported to authorized recycling facility and due record of the same should be maintained.
- Every worker working on construction site and involved in loading, unloading and carriage
  of construction material and construction debris should be provided with dust-mask to prevent
  inhalation of dust particle.
- Arrangement should be provided for medical help, investigation and treatment to workers
  involved in the construction of building and carry of construction material and debris relatable to
  dust emission.
- Dust mitigation measures shall be displayed prominently at the construction site for easy public viewing.
